WEEKLY SITUATIONAL REPORT ON COVID-19 PANDEMIC



PR 17th -24th April 2022 - The Ministry of Health confirmed 2,214 community cases over the last seven days from 2pm on the 17th April to 2pm 24th April, 2022. Total number of community cases is now confirmed at 8,280. Majority of community cases are confirmed in Upolu at 7,536 cases with 736 cases in Savaii and 8 cases in Manono Tai. There are twenty people in managed isolation and four in ICU at the Moto'otua Hospital.

Members of the public are reminded to remain vigilant and adhere to public health advice to wear face masks, maintain 2 meter social distancing in public places and ensure safe personal hygiene at all times. Those who are feeling

unwell are strongly advised to stay home and isolate to keep your families and loved ones safe. Please ensure eligible members of the household are vaccinated at the earliest possible. Vaccination remains our best defense against COVID-19.

COVID-19 related Deaths

Sadly, the Ministry of Health reported three new COVID-19 related deaths within this reporting period, bringing the death toll to 16. The public is advised that information about the deceased will remain confidential out of respect for the family.

S.N.P.F. pays out \$14.9 million in Interim Dividends so far...

CEO rubbishes Editorial Board

On the upside, 14,431 contributors of the Samoa National Provident Fund have collected their 5% interim dividend gifted by the Funds Board and Management to acknowledge their patronage as the SNPF celebrates their first 50th anniversary.

It translates to \$14.9 million cash received or close to 50% of the allocated \$40 million tala budgeted for contributors as part of the anniversary celebrations.

On the downside for the daily, SNPF’s Chief Executive Pauli Prince Suhren is ticked off again with the “sensationalized falsehoods” published in the Samoa Observers’ front page article headlined, “Minister demands explanation.”

Continued Pauli in his grievances;

“In the same article you make this egregious claim (emphasis is mine) – “The biggest dividend declared by the Fund was 9.1 per cent payout to its members that rolled out from 2019 up to March 2021 ahead of the General Election.”

“What stupid nonsense! Whose agenda is it are you peddling? I am appalled at the tenacity of your reporter to make such a claim. It stinks to high heaven.”

Pauli’s response is published below verbatim.

Dear Samoa Observer “Editorial Board”,

Times change but some things remain the same. The Samoa Observer continues to peddle sensationalized falsehoods. I used to suspect it, now I am absolutely sure of it.

Your article in today’s edition entitled “Minister demands explanation” is a classic example.

At the outset, I want to make clear that the Minister of SNPF has every right to query the decisions and the rationale behind those decisions of the Management and the Board.

This process is nothing new. Nothing sinister.

By my count, in the 50th year of the Fund, it has now served ten administrations since 1972 – and the process of back-and-forth dialogue and discussion between Minister and CEO/Board is absolutely normal, standard and expected. In fact – it is duty.

In saying that, I do believe that correspondences between myself and the Minister must remain private and confidential as these are important internal discussions.

But when you guys go and sensationalize the whole thing by printing excerpts of the Minister’s leaked letter from way back on the 16th of March and make it seem like there is some huge rift between the two parties is just disingenuous of you to say the least.

All in all, you fail to grasp the good that has been done. Or should I say you “refuse to grasp”?

Allow me to enlighten you once more on the FACTS you so clearly refuse to grasp;

You refuse to talk about the FACT that several thousands of members are receiving \$\$ in their pockets at this particular time when they need it the most - \$25 million this first round.

You refuse to talk about the FACT that 11,600 of our elderly community are receiving with great gratitude even just a little \$50 extra

this Easter.

You refuse to talk about the FACT that our members now have access for the first time to small loans and the payout itself through the online portal – meaning that on the first day alone of the payout - 4800 people were served online! Unprecedented.

You refuse to talk about the FACT that in the five years from 2017 to date the Fund has paid over \$309 million tala in dividends to its members - \$132 million of which was in cash. Unprecedented in history.

Shall I go on? Yes, I will.

In the same article you make this egregious claim (emphasis is mine) – “The biggest dividend declared by the Fund was 9.1 per cent payout to its members that rolled out from 2019 up to March 2021 ahead of the General Election.” What stupid nonsense! Whose agenda is it are you peddling? I am appalled at the tenacity of your reporter to make such a claim. It stinks to high heaven.

Here are the true FACTS recorded in history and chronicled in the annals of Parliament as per our Annual Report for that year ended June 2020.

The FACTUAL background behind the 9.1% declared in June 2020 is as follows:

1. The Fund paid out \$7.8 million in cash as an interim dividend in DECEMBER 2019. Why? The measles crisis was in full flow and our economy was already feeling the effects. Therefore, the Board resolved to act swiftly to help out our members in their time of need.
2. In March 2020 – the government declared a state of emergency due to COVID 19 – we are still in that SOE today in case you didn’t notice. What followed in the weeks and months after that was chaos “end of the world” kind of stuff globally with our own nation feeling the waves. There was anxiety over the possibility of an imminent outbreak locally if the virus hit our shores.
3. By the time it came in June 2020 to declare the final dividend – the Fund had already lost almost 3000 members due to layoffs especially in the hospitality industry and elsewhere because of the COVID 19 economic downturn.
4. Therefore, under those dire economic circumstances, the Board again swiftly resolved in June 2020 to declare 9.1% with 3 separate additional tranches for the remainder of the dividend to be paid in cash - \$14.2 million in July 2020, \$10.6 million in December 2020 and the final \$10.6 million in March 2021. In addition, \$21.3 million was credited into members’ contribution accounts for that same year. Why? Because our members were feeling the strain of the economic downturn and the Board acted accordingly.

You will note another FACT that in June 2021 – the board again declared another \$30 million that was paid in cash and another \$30 million paid into member contributions - was there an election then? Come on people.

What about this year 2022? You have again failed to grasp the FACT that there will be 3 tranches of the dividend this year – April, July and December 2022! Is there a General Election that I am not aware of this year or the next?

Stop peddling this silly, stupid, nonsense.

My advice to you is this – bring some real news worthy of your paper’s historical stature. Stop trying to create storms where there are none.

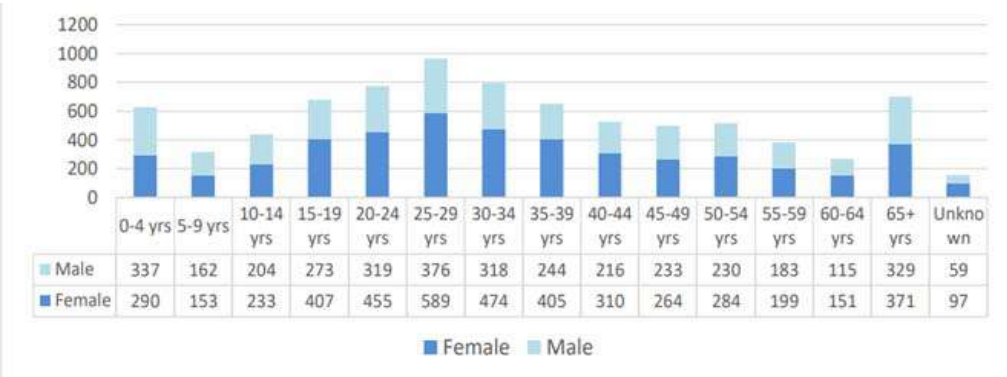
