




#### Figure 1. COVID-19 epicurve – New daily confirmed community cases by date of notification



## **IV.** Repatriation flights and quarantine update

#### As of 02:00pm Local Time June 26, 2022

- A repatriation flight FJ255 from Fiji arrived on June 25, 2022 with 149 passengers.
   All passengers were swabbed on arrival and COVID-19 PCR test results are still pending.
- A repatriation flight QF333 from Australia arrived on June 21, 2022 with 74 passengers.
  - All passengers were swabbed on arrival and returned 2 positive COVID-19 test results.
  - On Day 5 (June 26, 2022), 8 reported negative and 66 have yet to report.
- A repatriation flight NZ990 from New Zealand on June 19, 2022 with 293 passengers.
  - All passengers were swabbed on arrival and all returned negative COVID-19 PCR test results.
  - On Day 5 (June 24, 2022), there were no positive cases from the self-reports received (table 5 below).

**\*\***One passenger presented a Rapid Test Kit (RAT) without any official medical certificate to confirm it was theirs; they were denied entry.

## VI. Risk communication and community engagement update

- Continue to Disseminate all health information on preventive measures of COVID-19 through Vaccination Sites and media outlets
- Most Calls received at the MOH Call Centre since the 14th April, 2022 were public inquiries on vaccination sites and operations.
- Several issues raised through the media monitoring reports have been addressed by way of public notices, statements and reminders to the public to utilize government websites and Facebook to manage COVID-19 'infodemic' and misinformation.
