Govt. to deliver \$51 million tala election promise to Electoral Constituencies

Labeled by the Opposition as a deceptive election façade, Government will deliver that promise once Parliament gives the greenlight to the \$960 million tala Budget Estimates before July 01st.

Funding Government's \$1 million Tala District Development Project for the 51 Electoral Constituencies will be available from the Ministry of Women, Community and Social Development, (MWCSD)- \$63,679,430 million tala Budget request for the upcoming new Fiscal Year.

"The overall Aim of this Program is to inspire social harmony and inclusive growth for Samoa, through district developments utilizing our community capacities, natural resources and environment," the Budget Statement presented to the House by the Minister of Finance, Mulipola Anarosa Ale reads.

The Government focus is aligned to the Key Strategic Area 1 of the Pathway for the Development of Samoa:

1. Alleviating hardship
2. Improved Public Health
3. Quality Education
4. People Empowerment
5. Skilled Workforce

MWCSD in close collaboration with all other government agencies, will work to ensure the sufficient support is provided to effectively carry out the proposed initiatives from districts.



Minister of Finance Mulipola Anarosa Ale Molio'o signing on behalf of Government seed money of \$200,000 tala each for the 18 Districts which have completed the registration requirement to become eligible for the \$1 million tala District Project grant.

Initially 18 of the 51 Districts have received \$200,000 tala funding to prepare projects for submission to Government to be funded by the Project.

Signing of the grants between District Representative and Government to this effect took place recently with Finance Minister Mulipola Anarosa Ale.

Govt. tables \$960 million plus Budget for new Fiscal Year starting 01st July

The Government's proposed budget before Parliament for fiscal year 2022/23 which starts 01st July 2022 "is expected to record an overall deficit of approximately \$174.9million tala,"

"Under the Government Finance Statistics (GFS) format, this result in a deficit of \$77.2million tala or 3.5% of GDP," Finance Minister Mulipola Anarosa Ale Molio'o reassured the House in tabling the estimates earlier this month.

In her Budget Statement before the House, Mulipola explained that total Receipts and Grants for the Government is expected to drop by 12% in the new financial year "attributed largely to a reclassification of the Government of Samoa's grant financing, with General Budget Supports from key development partners to be reflected as financing of the budget deficit."

But on the upside, she noted that ordinary Receipts of Government which include both Taxation and Non Tax Revenues "are projected to increase by 1.3%."

Taxation Revenues of the Government

however are expected to increase by 5% attributed largely to the following:

- i. Increases in sin taxes in support of the Government's commitment to combatting Non Communicable Diseases (NCDs); and
- ii. Anticipated increase in economic activity, as Samoa's borders re-open to the rest of the world.

Non Tax Revenues are anticipated to de-

cline by 36% affected largely by the transfer of the motor vehicle registration and licensing function back to the Land Transport Authority from the Ministry of Police and Prisons.

Grant funding from traditional development partners to finance projects is predicted by the Finance will drop by "44% due to the reclassification of general budget supports of \$84.5million tala."

2022-2023 EXPENDITURE PRIORITIES

Total expenditures for the financial year 2022/23 is estimated to be \$964,835,276.00 tala which includes development programmes sourced by Samoa's development partners.

Meanwhile, Mulipola told the House the proposed budget will also increase Government's commitment to pay her debts with Statutory Payments to "increase by 21% as Debt Servicing normalizes following the expiry of the Debt Service Suspension Initiative."

Ministries' Expenditure Programs are also expected to increase by 21% in the new financial year, driven up by Ministry Outputs and Transactions on Behalf of the State reflecting the implementation of many of the Government's priorities and commitments as previously outlined.

On the other hand, development payments compared to the current financial year, have dropped primarily due to the completion of some grant financed development projects.

PATHWAY DOE THE DEVELOPMENT OF SAMOA

The Budget tabled before Parliament is aligned with the new Governments' Five Year Strategic "Pathway for the Development of Samoa (2021/22-2025/2026), which aims to achieve these key strategic outcomes including:

- 1) Improved Social Development,
- 2) Diversified and Sustainable Economy,
- 3) Security and Trusted Governance,
- 4) Secured Environment and Climate

Change

5) Structured Public Works and Infrastructure.

"The Budget is based on a conservative projection of ordinary receipts due to the impacts of imported inflation affecting all economies including Samoa. In addition, there are no new tax measures introduced, except targeted rise in sin taxes to support Samoa's Non Communicable Diseases (NCD) agenda, and a drop in import duties on selected ICT items, to support Samoa's digital transformational agenda," continued Finance Minister Mulipola.

READINESS FOR DISASTERS

To ensure Samoa's readiness for disasters including health emergencies, the 2022/23 budget, will include budgetary provisions for Emergency Response Operations under Ministries with frontline responsibilities, such as;

- 1) Ministry of Health
- 2) Ministry of Police & Prisons
- 3) Ministry of Agriculture and Fisheries
- 4) Ministry of the Prime Minister &

Cabinet

5) Ministry for Customs and Revenue
6) Ministry of Natural Resources & Environment

7) Ministry of Finance and the Fire & Emergency Services Authority.

"This is in addition to the unforeseen appropriation in the budget and Samoa's standby facilities with the World Bank and the Asian Development Bank," explained Mulipola citing some of the financing instruments highlighted in the Disaster Risk Financing Policy 2022/2025 which includes;

- i. Improve revenue collection by enforcing compliance and monitoring on Taxes; and
- ii. Ensure efficient and effective utilization of budgetary resources by Ministries and Public bodies, based on their respective Government strategies and policies

Parliament is scheduled to return to session before July 1st to pass the new Fiscal Year Budget.

MESC - Living with COVID19

Hard on the heels of the 2021 Measles Outbreak, the COVID19 pandemic took the world by surprise without exemptions. And for two years, the globe remains hostage to the deadly virus claiming millions of lives including 28 in Samoa as of June 9th.

To protect local residents, Government initiated the Mass Vaccination Campaign with special attention to our most vulnerable groups which include our young children and senior citizens.

And to date Government is not sparing any resources in protecting our borders as evidenced by Border Security Mandates to isolate and quarantine new arrivals testing positive at the Airport.

Meanwhile, the vaccination coverage rates are high in all age groups, but the Ministry of Education, Sports and Culture, (MESC) is not sitting on its laurels and playing its role to be part of the solution and not the problem.

As a life saving measure, MESC is dedicating part One Government Grant for Schools (pre-schools, private and mis-

sion) of her \$17.7 million tala budget allocation to adapt the new Living with COVID19 framework norms and ensure sectoral goals are achieved.

The proposed funding is part of the \$132.5 million tala Budget that MESC is requesting Parliament to authorize to finance their operation, outputs and key developments for the new Fiscal Year which starts July 01st 2022.

Along with the \$17,726,320 for the One Government Grant for School assistance for schools which will remain at current levels, to support continued efforts to adapt to the new norms under the COVID-19, and ensure sectoral goals are achieved the Budget request also includes

- \$19,720,627 for the National University of Samoa
- \$6,426,232 for the Samoa Qualifications Authority
- \$2,145,965 for the Samoa Sports Facility Authority

For the new Fiscal Year MESC's budget request for funding under her Key developments framework include:

- \$2million tala for Sports Development, in partnership with the Gaming Control Authority (GCA)
- \$50,000 for the Samoa Arts Council,

This appropriation reflects the Government's commitment to unlock and promote the potential of the creative arts and talents of our local people for income generation opportunities and national development in the future. The completion of the Arts and Culture Centre is crucial to ensure that our people remain culturally connected, enhance social cohesion and support creative arts agenda.

\$76,403,345 million will cover the Ministry's Operations while \$10,166,697 million tala will be set aside for Transactions on Behalf of Government.

And Government according to Finance Minister Mulipola "will continue the partnership with our development partners on inclusive education, construction of new primary school buildings, increase of TVET scholarships and the construction of the new Faculty of Health science facility for the National University of Samoa (NUS), as well as the expanded information technology support for both primary and secondary schools."

Govt. to deliver \$51 million tala election promise to Electoral Constituencies

In her address, Finance Minister Mulipola told the District representatives that it was not an easy endeavor due to differences on aligning and complying with National Priority Goals and Policies of the Government and sustainable development goals and projects within Samoa's 51 ballot constituencies.

\$10.2 million tala is set aside to finance the initial funding for the 51 constituencies.

This grant is for the first phase of the project which includes 18 district councils that complies with criteria or requirement of the project submitted to the Ministry of Women Community and Social Development and the signing of the funding agreement today is for the disbursement of the \$200,000.

Honorable Mulipola also mentioned that a different funding agreement will be signed on the disbursement of the 1 million tala for the second disbursement of the grant for each District Councils.

She reminded the districts representatives that the signing of this funding agreement will be only for the \$200,000.00. The trust is with the District Committee of each districts to ensure compliance of the funding agreement for the establishment of the District Councils, Establishment of DC offices and Recruitment of personnel for the project and development of each districts.

She clarified the criteria / requirement needed and highlighted the importance of submitting a written reporting clarifying the utilization of the \$200,000 before 31st July 2022 by each District Councils committee. She also stated discussion on the utilization of the 1 million will be initiated once all District Councils comply with requirement of the funding agreement on the utilization of the \$200,000 including monitoring and evaluation visits by government officials as these are same measures / requirements with regards to the utilization of the 1 million tala.

A request for each District Councils to start discussion on the utilization of the 1 million tala with the MWCSD. A Project Management Unit (PMU) will be established to monitor the progress of this project in collaboration with the MWCSD to en-



sure development in each DC will contribute to the current especially the future development of each DC.

The Minister re-emphasized that the Government wishes for the District Committees to use this golden opportunity for districts to implement and develop new sustainable development initiatives, for improvement of current livelihood and future development endeavors for district and families. The Government aims for District Committees

to prioritize and well implement this new initiative for the betterment of families, villages and country as a whole.

To complement the District Development Project funding is also requested to strengthen Non-Government programs partnering with the Ministry.

The requests includes;

- \$300,000 tala for ongoing support to Komiti Tumama

- \$500,000 tala for NGO programs on Women, Youth and Children

"We will continue the partnership with our development partners for capacity development for the Ministry in its supporting role for the implementation of the District Development Program and other community initiatives," assured the Finance Minister.

Export Authority to receive \$300,000 funding injection

Government is proceeding with setting up the Samoa Export Authority (SEA) in line with its Strategic Plan to generate new income opportunities for farmers and reduce the country's reliance on exports.

Included in the Ministry of Agriculture and Fisheries Budget request for funding is the \$300,000 allocation designated to continue preparatory phase in establishing the Authority.

The Authority will take over the duties and responsibilities to secure overseas market for the countries agricultural crops and fish instead of local exporters struggling to find new opportunities independently, Agriculture and Fishery Minister La'auli Leuatea Polataivao Schmidt told Parliament recently.

For the exporters benefit and smooth transition the Government's Warehouse in New Zealand will be fully utilize and open to all local exporters for storage purposes and to sell their fruits of hard labor.

Central to the plan to maximize export outlets, the Otahuhu based warehouse will also serve as a transshipment hub for all Samoan grown and Samoan made agro exports targeting lucrative markets not only in New Zealand, but Australia, Asia and USA, the Minister told the House.

Part of the plan in motion will see MAF sub-divided into two Ministries, one for Agriculture and the new Ministry of Fisheries.

Commercializing the country's fisheries sector is a top priority, the Minister says noting that presently two companies are operating out of the Matautu-International Port exporting frozen fish and there is room to increase Samoa's frozen fish export volumes.

On the upside, the Minister noted that there are over 200 fishing vessels operating in international waters and Samoa's EEZ supplying the raw fish and the spin-offs translates to new jobs and fresh revenue to purchase the fleets supplies while off-loading their cargo.

Local fishing operators are also in the equation and already popular fish delicacies such as poge, ume, etc. are now included in the frozen fish export with the first recent shipment to overseas market.

"These undertaking are all subject to Cabinet approval and it's our local agricultural and fisheries stakeholders who stands to benefit," he reiterated.

The Authority is part of an ambitious and no holds barred strategic plan for Samoa to realize her full Agro-export capacity with farmers, fishers, their families, villages, our economy, Gross Domestic Product-(GDP) and Foreign Reserves among the top primary benefactors.

As part of the renewed effort, reducing Samoa's reliance on imported meat products is also on the menu.

ANNUAL FARMERS SHOW, PACKING HOUSE IN SAVAI'I ETC

On the local front, La'auli also shared with House the Ministry's new directives already rolled out which he says will add more value to the \$500,000 tala approved budget to stage and host the National Farmers Show.

Instead of the annual show, the allocated half a million tala budget has been re-directed with \$200,000 to fund a Packing House in Savai'i. The Big Islands' farmers, fishers and livestock owners do not have that luxury and presently pack their fruits of hard labor from under a breadfruit tree for tranship shipment to Upolu for the local and overseas markets.

But with the Packing House, the Minister is adamant that fresh crops will not rot during

shipment. Certification for Samoan Agro-exports to meet the tough international quarantine and associated requirements will also be in place for all goods processed by the Packing House.

Also instead of the annual Farmers Show, Talomua for the respective constituencies is the new MAF approach with \$180,000 tala re-directed from the half a million is redirected to help the Pulega a Ali'i ma Faipule with administrative expenses, prizes and related costs.

"MAF is giving back the ownership to the Village Councils, farmers and fishers to take charge and the Talomua is designed to motivate them to be part of our mission to maintain the country's food security using our land and ocean natural resources as we have done for many many years," he elaborated.

The balance of \$120,000 will go towards the procurement of a transformer to revive the Government's Feed Mill. It is part of the overall plan to boost agro exports and reduce reliance on imports.

Health tops Government's Priorities

Health remains the #1 Government priorities as articulated by the 2022-2023 Budget Estimates tabled before Parliament for legislative review and endorsement to become the Government's Budget Law and bible for the next 12 months starting 01st July.

The Ministry of Health stands to receive the biggest budget with a dose of \$140.4 million tala worth.

It includes \$550,000 grants for active Non-Government Organisations within the sector and are partners with the Ministry in delivering health services.

The NGOs include;

- Samoa Red Cross
- Samoa Cancer Society
- GOSHEN Trust
- METI
- Agape Clinic
- Samoa Family Health Association

The assistance is allocated under MoH's Outputs by third parties which also covers;

- \$9,329,934 for the National Kidney Foundation;
- \$5,000,000 for the country's Overseas Medical Treatment;
- \$250,000 for the Non Communicable Diseases Clinic

For the Ministries key developments for the new financial year half a million or \$500,000 tala will be allocated for emergency response operations under State of Emergency Declaration.

Other Key Development allocations include;

- \$1million tala for refurbishments of rural district hospitals;
- \$1million tala to continue the construction of residences for medical personnel;
- \$3.9million tala for continuing the programs and initiatives to combat NCDs;
- \$1.5million tala to continue the Returning Graduates Program for health care professionals.

Over \$100\$ million tala or estimated 108,414,360 will be assigned as outputs delivered by the Ministry while the balance of \$16,899,304 will fund Transactions by MoH on Behalf of Government.

"We will continue the partnership with our development partners to implement the programs to combat NCDS, the COVID-19 response efforts, the roll out of vaccinations for children's prevention against pneumonia, typhoid and cancer, as well as capacity building for the Health Sector," elaborated the Minister of Finance Mulipola Anarosa Ale Molio'o in her Budget Address.

Govt. earmarks \$13 million plus for Tourism & Private Sectors

If passed into law, the Private Sector and the Tourism Industry will share close to 60% of the Ministry of Commerce, Industry and Labor's Fiscal Year 2022-2023 Budget.

That's \$13 million tala plus change.

In the Budget Estimates now under Parliamentary scrutiny the Samoa Tourism Authority, (STA) will receive \$9.5 million tala, inclusive of \$2.5 million tala for the continuation of Tourism Recovery efforts, as implemented in the current financial year, of which approximately \$4million tala of the \$5million tala appropriated, is disbursed to date.

More than 160 hotels and beach fale operators, travel agencies and tour operators have benefited from this initiative);

Also in MCIL's Outputs for the Private Sector includes;

- * \$450,000 for the Samoa Business Hub;
- * \$3,000,000 as Private Sector Support Financing (MSMEs) This will be implemented by the Samoa Business Hub.

For its operation, the Ministry is requesting Government to approve close to \$6 million tala, \$5,706,507 millions tala for outputs delivered by the Ministry and \$2,045,383 million tala for Transactions on Behalf of Government.

THE SAMOA HIGH COMMISSION TO FIJI HAS FINALLY OPENED ITS NEW CHANCERY IN SUVA

(PRESS RELEASE)- Samoa's High Commission to Fiji, though formally established on 5th March 2021, had been operating temporarily from the homes of the High Commissioner and Student Counsellor until its first chancery in Suva was officially opened on 7 June 2022. High Commissioner Aliioaiga Feturi Elisaia was Master of ceremony and commenced the programme by welcoming and 'Faafeiloai' the main guests to the event. Rev. Siu Vaifale of the Samoa Congregational Christian Church in Suva led the convocation and shared passionately about the significance to the Samoan community of the opening of the Samoa House in Suva.

The Hon. Fiame Naomi Mataafa provided the official remarks before the Hon. Josaia Voreqe Bainimarama was invited to deliver the host country remarks. Both leaders shared their excitement on the establishment of the Samoa High Commission in Fiji, which will only further strengthen the relationship between the two Pacific neighboring countries. The Hon. Bainimarama congratulated the Hon. Mataafa on becoming the first female Prime Minister of Samoa. The appointment of one of Samoa's most senior diplomats, High Commissioner Elisaia to establish the High Commission in Suva was also acknowledged by both leaders as a sign of how significant this post is for Samoa and its relationships with Fiji. Hon. Mataafa also thanked Prime Minister Bainimarama and his Government for accepting Samoa's request to have a physical diplomatic presence in Fiji.

The remarks of the two Leaders was followed by the ribbon cutting ceremony performed jointly by them to officially open the chancery, after which they were taken for a tour inside the High Commission's two story building.

At the conclusion of the formalities, the High Commission hosted a reception for the invited guests outside of the chancery where they were also entertained to Siva and Faafiafiga by the USP Samoan students.




