Faleolo International Airport on the comeback

The Faleolo International Airport terminal is returning to life with new international carriers given the green light to commence scheduled flights to Samoa now that the country's borders are opened since August 1st.

As of this week, Fiji Airways was granted the go-ahead by Cabinet to commence a weekly service to Honolulu originating from Nadi-Faleolo-Honolulu and on the return leg.

The latest permission complemented Fiji Airways three week-

ly direct flights between Nadi and Faleolo.

Qantas Airline is also back with a weekly direct flight originating from Sydney while Air New Zealand is flying in and out of Samoa four times a week.

Airline sources have also confirmed that Virgin Australia who severed ties with Samoa several years back is on the comeback and reportedly will resume services come January 2022 subject to successful negotiations between Virgin Airlines and Minister of Transport Olo Fiti Vaai.

Tapping into the lucrative U.S. Trade Market

Tapping into the lucrative U.S. Trade market is back in the limelight for all the right reasons.

To infiltrate the U.S market, Samoa relentlessly has been working with the American Samoa Government via the annual 2 Samoa talks between the territory and local government for 39 years since the annual talks was established begging Uncle Sam to relax her tough federal regulations and compulsory quarantine mandates.

And after a four year lapse prompted by the COVID19 pandemic on the heels of the Measles the unresolved trading partnership arrangement designed to strengthen trade with the territory as a transshipment stop for Samoa's agricultural produce and Samoa Made exports such as chocolate, coconut cream body lotion, shampoo, whiskey, beer, breadfruit flour to enter the U.S. supermarket shelves and Trade markets is back on the agenda.

Come September, American Samoa Government Governor Lemanu Peleti Mauga will lead his Government delegation to Apia for the 2nd round of talks between the 2 Samoas now re-named as the Atoa o Samoa Executive Meeting since the two new respective Governments took up office more than a year ago.


And the long standing Samoa-American trade vacuum is one of the priority issues.

Last week-end, a senior U.S. official, the Deputy Secretary of State Wendy Sherman also acknowledged the web of hurdles concealed in the federal regulations which is creating trade barriers between the two Samoas.

The US has shown its commitment to boosting ties with the Pacific after President Joseph Biden extended an invitation to the leaders of the Pacific Islands Forum (PIF) to Washington DC next month.

The US President's invitation was announced on Friday by Deputy Secretary of State Wendy R. Sherman in a joint Press Conference with Samoa's Prime Minister Fiaame Naomi Mataafa, where she had reiterated her country's support for a strong and united PIF.

"The President of the United States is looking forward to welcoming Pacific Island leaders to the White House in September around the UN General Assembly, we hope to announce a date very soon," Deputy Secretary Sherman says.

The US' first female Deputy Secretary of State visited the country on Friday, before flying over to Tonga, Solomon Islands, Australia, and

New Zealand.

"I am thrilled to start my trip to the region here in Samoa which is the United States Pacific Island neighbor, our strong partner, and our good friend," she says.

The US and Samoa share a commitment to important democratic values including respect for human rights, a commitment to protecting freedom of expression, and freedom of religion or belief, and according to the Deputy Secretary, a strong belief in the importance of a free and open Press.

Prime Minister Fiaame was happy to hear of the invitation and looks forward to joining Pacific leaders next month in the US Capital.

"We do look forward and we are very happy to take note of the indication that your President would like to meet with the Pacific leaders later in the year and we look forward to that opportunity," Prime Minister Fiaame says.

Tapping into the lucrative U.S. Trade Market

Transiting through Samoa as part of a Good will tour of the Pacific, the U.S. Deputy State Secretary in a joint Press Conference with Prime Minister Fiaame Naomi Mataafa Sherman Friday last week acknowledged that there are oversights in the federal laws.

"One of the things that the Prime Minister raise which I thought was quite right is that particularly in smaller countries our bureaucracy can sometimes seem overwhelming that the processes are so complicated and things take so long and smaller countries may not have the depth and breadth of people simply to manage all the paper work that is necessary," she told the local media.

And as the longest serving Cabinet Minister and now Prime Minister Fiaame is fully aware of the players when it comes to trade issues with the US via American Samoa,

"It did come up in the two Samoa talks and of course as you indicated it has more to do with U.S. requirements, so essentially it's an

issue for American Samoa to try and resolve whether they might have some sort of dispensation if it is just between the two Samoans but the requirements for the whole of the United States," said Prime Minister Fiaame.

She noted that American Samoa will "take the lead on talking to the appropriate authorities on how the issues might be resolved and it may not only just be meat, (exports) but if that there are federal requirements then it's a whole range of discussions that need to take place."

While awaiting the next round of talks there are published bird's eye view without a full understanding and appreciation of the turmoil endured by the government officials to secure a financially rewarding incoming source for farmers and the local manufacturers.

Local manufacturers will attest that their primary target is the U.S. niche market to sustain the U.S. supply and demand but federal regulations and requirements are in the way.

Than employment opportunities over the years have been a gold mine for many local families.

A pocket issue for low income families, the exclusive "Guest Workers" permit for the locally unemployed to secure jobs as fish cleaners with Star-Kist Samoa canneries, the single largest employer in the territory has recruited close to 1,000 Samoan. The new permit arrangement is identical to the Seasonal Workers program between Samoa, New Zealand and Australia respectively.

There is also prospect for local businesses to expand into the territory for instance banking institutions.

With the ANZ Bank closing down its American Samoa branch, Prime Minister Fiaame has followed up with Governor Lemanu to revisit past mutual understandings for ASG and the territory's private sector to resurrect business partnerships with the two Samoans.

US in the Pacific to listen and learn

The most Senior US Diplomat to visit Samoa's shores Deputy Secretary of State Wendy R. Sherman is looking forward to the two countries working hand in hand in education, health, and combating the climate crisis.

In a joint Press Conference on Friday with Samoa's Prime Minister Fiame Naomi Mataafa, Deputy Secretary Sherman said that she is here in the Pacific to listen and learn from her brothers and sisters in the Pacific.

"We are one Pacific family bound together by our history our values, our culture and our shared priorities, and there is no limit to what we can achieve when we come together as partners," says Deputy Secretary Sherman.

The US assistance to Samoa on education through the Peace Corps programme, says Deputy Secretary Sherman, looks forward to the return of the volunteers after a two year absence in the nation.

"Over the last 55 years more than 2,000 Peace Corps volunteers have served in Samoa, an incredible symbol of the partnership and friendship between our people," she said.

In terms of health assistance, the US has shared over 45,000 doses of the COVID-19 vaccine with Samoa through COVAX, according to the Deputy Secretary, and stated that their country will stand together with Samoa to combat the climate crisis.

Their assistance is also extended to security, where the US Coast Guard has stepped forward to conduct patrols on Samoa's Exclusive Economic Zone in the absence of a Guardian Class Patrol Boat.

Prime Minister Fiame was thankful for the visit by the US Diplomat, and had acknowledged the assistance the US has offered to Samoa.

"We are very pleased, and Deputy Secretary has very kindly indicated that she is here to learn and to listen, but it is also an opportunity for us here in Samoa and for myself as the leader to have firsthand discourse with this level of representation from the United States Government," Prime Minister Fiame says.

Netzler, longest serving Cabinet Minister laid to rest

The late Jack Olaf Netzler is in Samoa's history books as the first Cabinet Minister to serve under the leadership of two Prime Ministers and one of the longest serving Member of Parliament representing the Individual Voters.

Netzler entered Parliament in 1981 as a Member of Parliament for individual voters under the Human Rights Protection Party (HRPP) and served the majority of his 20 years in the political arena as a Cabinet Minister under the leadership of Prime Minister, the late Vaai Kolone and the late Tofilau Ale-sana.

The life of former Cabinet Minister Jacob John Olaf Jack Netzler was honored on Saturday in a state funeral.

Jack passed away on the 2nd of August and a state funeral that was held at the Mulivai Cathedral on Saturday.

Prime Minister Fiame Naomi Mataafa spoke of the life of Jack and his long service to Government and the people of Samoa.

"Jack became Minister of Agriculture on the 20th of April 1982 under the leadership of Prime Minister Vaai Kolone," says Prime Minister Fiame.

From 1988 to 1991 Jack took on the role of Minister of the Post Office, which the Prime Minister says was during the years that Cyclone Val and Ofa had affected the country's economy, which had then been followed by the Taro Blights of 1993.

In 1992 to 1996, he became the Minister of Transport. He

had also taken up roles in various Parliamentary Committees.

Prime Minister Fiame explained that Jack had served the Government for 20 years many of which he had served as a Cabinet Minister for Ministries who played a leading role in the development of the country.

"The last time he spoke in Parliament he talked about the land, fisheries, wharfs and airports, roads and clean water for the country, trade between Samoa and American Samoa, and creating more job opportunities for the people of Samoa," Prime Minister Fiame reminisced.

"I thank you for your service to the Government, and your courage to serve the country," she concluded.

Dedicated education stalwart Esekia laid to rest



12 April 1945 – 27 July 2022

To the public, he was Mulitalo Ali'imua Esekia Solofa.

To his close friends and colleagues, he was simply Esekia, a quiet education stalwart who lets his work and achievements do the audible talking.

Armed with a Bachelor in Science from New Zealand after graduating from the Vaivase Samoa College, Esekia started his public services to his country as a postal staff then moved on to work with National Broadcaster Radio 2AP.

He finished off with a diploma in education before he returned to teach at his old school at Samoa College and went on to become school principal.

In 1970 he debut as a teacher, to start a ten year span as an educator.

And in 1976, the quiet mathematician was promoted to Samoa College Vice Principal and 2 years on became Principal.

In 1980, his civil service career took a leap when he was made Chairman of the Public Service

Commission for the next three years.

In 1989 he was successful in his studies for a Masters in Public Administration at Harvard University in the United States.

Esekia would spend several years in the service until he shifted to still another higher level of civil service and a return to his preference as an educator.

In 1992 he was appointed Vice Chancellor of the University of the South Pacific to be based in the university campus in Suva, Fiji.

Mulitalo returned to Samoa to continue as his services as the Member of the Remuneration Tribunal before he was passed on 27th July 2022.

He was 77 years old.

Mobile Wallet to benefit SNPF pensioners

Hundreds of pensioners under the Samoa National Provident Fund Senior Citizens Program are beneficiaries of new joint initiative by Digicel Samoa and Samoa National Provident Fund (SNPF a.k.a NPF0.

The senior citizens can now access their monthly pension through the convenience of their phone thanks to the new partnership.

The Chief Executive Officer of the SNPF Pauli Prince Suhren said on Monday in a joint Press Conference with Digicel Samoa Chief Executive Officer Seiuli Deepak Khanna that they have been working in partnership with Digicel for 16 years.

Their new initiative has been months in the work which will ease queues at the SNPF buildings, save money from travel during payout of pension to senior citizens every month.

Pauli said that senior citizens can receive their pension through MyCash.

“They will have to register on level one of the SNPF building, and then they can use MyCash to receive their pension,” Pauli says.

The service is not only for senior citizens as Pauli announced that the service is also extended to all SNPF members who have registered and downloaded the app, as payments for loans can be done using Digicel’s MyCash.

“We are well in advanced in the 21st Century and we want to use technology to the best that we can to make it more efficient for our members and to make it easier for our members as well,” he says.

Seiuli said they are “taking a step in a new journey” with SNPF in Samoa’s digital economy in what he called a perfect partnership.

“With SNPF celebrating 50 years it’s another amazing year,” Seiuli says.

He added that their MyCash app can be utilized for many things such as making EPC payments or purchasing items from stores such as Samoa Stationery and Books.

“It is basically the digital wallet and the digital commerce platform coming together as one,” he says.

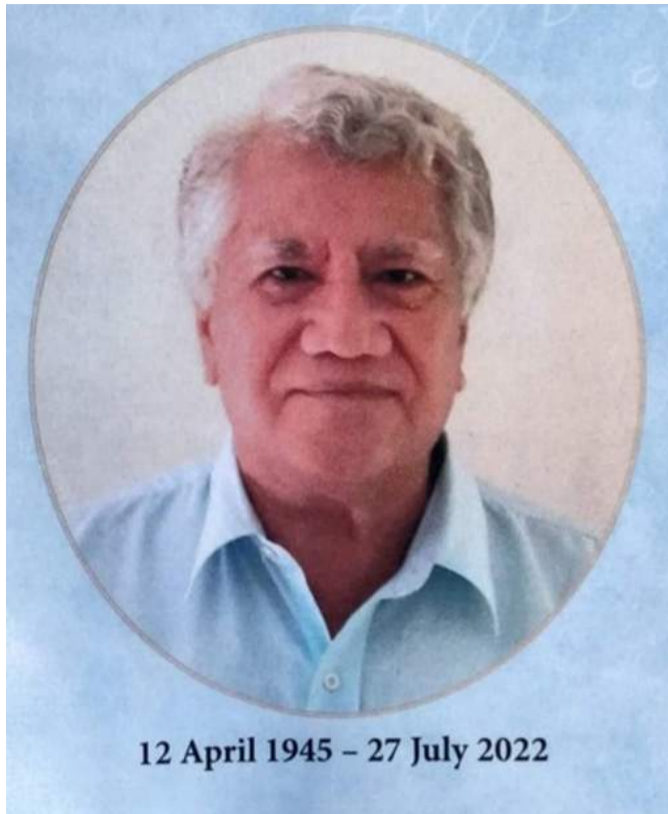
