# Australia reveals sponsorship of Manu Samoa at Rugby World Cup 2023

Australia's Minister of International Development and the Pacific Pat Conroy has announced his government's sponsorship for Manu Samoa's preparations for the World Rugby Cup in France this year.

And the sponsorship includes a financial support of AUS\$220,000 (SAT\$ 402,592) he said.

The reveal was announced at the Lakapi Samoa Headquarters yesterday in a short formal ceremony to officially launch PacificAusSports

partnership with Lakapi Samoa.

This means that the PacificAusSports brand will be sewn onto the Manu Samoa jersey among other activities included under the sponsorship.

And, Australia's support for the Manu Samoa during the Rugby World Cup Campaign was a sponsorship his government was proud to be backing said Conroy.

"Australia shares a rich history and deep love of sport with Samoa and that has helped to sustain our relationship on and off the field," he said. He also pointed out that there were many symbolic ties that bind the



#### Australia reveals sponsorship of Manu Samoa at Rugby World Cup 2023

two countries including the captains of Samoa and Australia's national teams, the Ala'alatoa brothers, but equally symbolic the support for Samoan rugby through the PacificAusSports.

Minister Conroy said the newly revealed support follows on from previous support for Samoan rugby including the Samoan independence Rugby 7th tournament in September last year, and the Manu Samoa's very successful 2022 Pacific Nations campaign, where Samoa defeated Australia A, Tonga and the historic come from behind victory against Fiji to take out the cup.

The Minister was all awes and congratulations, "so great achievement", he said. He said, the support was also in addition to Australia's support for Oceania rugby, and creating pathways for women's Samoan rugby players to compete at elite level, including through supporting development of Samoa's National Women's 15's rugby championship, the first ever Oceania women's combined held in 2022 and two Samoan women have been awarded Pacific all sports scholarships to play Australian super W clubs in 2023.

But, the Minister said their help extends beyond Samoan rugby union, his country was also proud to support Samoan netball and rugby league.

"Australia is proud to support Manu Samoa, PacificAusSports is proud to be in this partnership, to help grow rugby in this country, to help support pathways and grassroots, and it is great to support your presence at rugby world cup in France later this year."

He wished Samoa all the best of luck at the Rugby World Cup but reiterated his support of the Manu Samoa by saying that he hopes desperately for a repeat of exploits from 1991 so Samoa can show what a proud upstart nation can do.

Chairman of Lakapi Samoa, Tuilaepa Sailele Malielegaoi however had a message for the Minister to take back to Prime Minister Anthony Albanese.

And that message is for Australia to bring their team to Samoan soil to play.

Tuilaepa said the previous Prime Minister Scott John Morrison had broken his promise to him that Australia will be coming to play in Samoa and that is why he lost the election.

Thus, he urged Minister Conroy to relay this message to P.M. Albanese so that it might finally happen.

He expressed thanks to the Government of Australia, the Department of Foreign Affairs and the support from Australian High Commissioner in Apia.

"The partnership will see the PacificAusSports brand on the back of the Manu Samoa jersey and also assist growth of sport in Samoa, through various initiatives in allowing Lakapi Samoa to host domestic tournaments both for men and women 7's and 15's.

He said this holds a pathway to build up local talents and raise the standards and profile of the game in Samoa, and allowing Lakapi Samoa to invest and upskill local administrators and managers. He also noted that the funding will go directly into the High-Performance Academy to grow and nurture talent to become elite professional players.

Tuilaepa added that all the support from Australia benefits the next generation of Manu Samoa players both men and women.

And he looked forward to fostering this relationship with renewed confidence that the initiatives will allow sports people to excel and play to their full potential.


