Outstanding Debts down, Foreign Reserves on the rise

At the end of June 2023, Samoa's Gross Official Foreign Reserves had passed the \$1 billion tala neighborhood with the official amount of \$1,098.09 million tala listed in the Report on the Macro-Economy for Financial Year 2022-2023 Report up to June of this year issued by the Central Bank of Samoa.

"At this level, this was sufficient to cover 10.9 months of imports," said the report which is sending reassurances that at times of natural disasters which may cripple the country, the reserve will finance imported essential supplies such as food for close to 11 months.

The current balance represents a 35.1 percent higher than the same month last year, continued the report.

Consequently, Samoa's Foreign Reserves Capacity set a historical record of passing the \$1 billion in reserves in May of this year.

EXTERNAL DEBT OUTSTANDING (at the end of March 2023 quarter.)

During the period under the microscope, the country's External debt outstanding had dropped to \$882.06 million or 7% lower compare to \$948.46 million tala in March 2022.

Funds to pay the country's outstanding debt are statutory expenditure mandated by the constitution to be included in the Government's Annual Budget year in and year out. And for the current fiscal year, the Annual Debt Servicing at the end of March was clocked at \$94.46 million tala which was 56.0 percent higher than \$60.55 million tala in the year up to March 2022.

According to the Central Bank, "This large hike reflects the end of the Debt Service Suspension Initiative (DSSI), which Samoa was a part of, and the resumption of normal debt servicing repayments. This was equivalent to

Twin VS Twin- Electoral Violation

A twin who cast his vote in his brother's name in the Vaimauga No. 3 by-election has pleaded not guilty to the offence. And a hearing is scheduled in the court on 25th October.

According to the Electoral Commissioner, Tuiafelolo John Stanley the offender is a registered voter for the Vaimauga No. 4 Electoral Constituency.

But he allegedly voted on behalf of his twin brother who is a registered voter for the Vaimauga No.3 Electoral Constituency.

And the Electoral Commissioner revealed that the alleged illegal voting was discovered when the brother who was impersonated was stopped from casting his vote at the ballots of the Vaimauga No. 3's recent by-election.

The illegal practice was confirmed by the O.E.C.'s Vote Count App prompting legal actions.

Tuiafelolo did not mince his words when he said this was a deceiving act and unacceptable under the Electoral Act 2019.

Under Part 13 Corrupt and Illegal Practice of the

Electoral Act 2019 an offence of this nature is termed Personation and falls under Section 95.

RSE Policy Proposal scrutinized

Tabled before Cabinet is a policy proposal addressing the selection process for residents applying for seasonal work in New Zealand and Australia.

And one of the key recommendation will be initial application, screening and selection to be administered by the 51 respective District Development Offices before they are submitted to the Ministry of Commerce, Industry and Labor, (M.C.I.L.) for final review.

The new approach is one of the proposed changes prescribed by a Cabinet appointed Committee, chaired by M.C.I.L. Minister Leatinu'u Wayne So'oialo to research and submit a policy plan recommending guidelines to ensure that the RSE genuine objective exclusively for the unemployed only is not compromised.

Secondly, the policy is designed to protect the interests and welfare of local businesses from losing skilled labor to the Seasonal Workers lucrative high salary attraction.

The policy proposal also includes guidelines of Mcriteria for the District Development Offices to implement

their selection process.

One criteria to be eligible to apply is for the applicant to be a registered voter of the Electoral Constituency which he is applying from, Leatinu'u explained exclusively to the Savali.

Confirmation is also compulsory from the Samoa National Provident Fund that the applicant is not a contributor or have not paid his Fund contributions for 6 consecutive months.

A police report is also compulsory and if the applicant has a record, his application will be denied.

Leatinu'u admits that it's publicly documented and evidenced by Social Media posts that full time teachers and police officers have resigned from their job to take up seasonal employment which defeats the mandate of the RSE initiative for the unemployed only period.

Without going into details out of respect for the Cabinet decision making integrity, the Minister says that District Development Offices and Village Councils (Pulega Ali'i ma Faipule) are also recommended to take charge and responsibility in handling cases involving Samoan workers returned home for violation of their seasonal working contracts.

But it's crucial that these decisions are relayed to the M.C.I.L. to ensure that there is fairness and equal opportunity for the benefactors especially people in the districts needing employment to support their families.

"The policy is giving ownership to the villages to ensure a fair selection process and the RSE mandates are not manipulated or violated," reiterated Leatinu'u.

Full details of the new RSE Policy are expected to be revealed at the completion of the Cabinet scrutiny.

Public to keep in mind that it is an offence under Section 63 of the Act not to register when you are of age.

VAIMAUGA NO.3

For Vaimauga No. 3 according to records following the 2021 General Elections 2,044 registered voters did not exercise their democratic right to have a say in the selection of their Electoral Representative. Vaimauga No.3 has over 4,000 registered voters.

According to Tuiafelolo after seeking immigration records to identify those travelling at the time, OEC was left with 922 voters who did not cast their votes.

From that 922, 72 were identified to have been in the country but had not casted their votes.

The commissioner pointed out other reasons for registered citizens not casting their votes at the by-election of Vaimauga No. 3 include; attending RSE work, have passed away, moved overseas and for related personal reasons.

As a result and as prescribed by the Electoral Act, the 72 registered but did not vote is now subject to scrutiny which include notices seeking the reasons for not voting.

Failure to respond will attract a \$100 fine.

And there are other requirements articulated by the Electoral Act which include Failure to register that could lead to a \$2,000 tala fine.

"The elections is the duty of any Samoan 19 years and over. It is the duty of every voter qualifying under this Act registered as a voter, to vote at each election," reminds Tuiafelolo.

"The law is the law. It is essential that it is adhered and obeyed to reduce costs and penalties it effects due to not taking it seriously."

PRIVATE REMITTANCES

In the 12 months to June 2022, remittances soared to \$832.13 million representing 13.6 percent hike compared to \$732.43 million in the twelve months to June 2022.

Family and Households showed a major jump by by 7.1 percent to \$714.80 million while Non-profit Institutions Serving Households (NPISH) increased by 0.7 percent to \$32.30 million; Hand carried cash expanded by \$55.27 million to \$65.02 million.

TOURISM REVENUES

In the 12 months period up to June this year, tourism revenues was tallied at \$402.99 million tala From that total, \$206.71 million tala or 49.1 percent was injected by visiting friends and relatives with the balance of \$131.61 million tala (31.3 percent) spent by holiday visitors.

Visitor Arrivals and Receipts

Total Arrivals

124,655 visitors in the twelve months to June 2023.

- Of which 51,924 (41.7percent) were those of visiting friends and relatives;
- 43,639 (35.0 percent) were those on holiday.

With the by-elections to determine the successful candidates to represent the Parliamentary seats in the Legislative Assembly for Siumu, Faleata No. 4 and Vaa-o-Fonoti just over a week away, the Electoral Commissioner has confirmed 8 nominees.

Candidates contesting the seats for these constituencies are; Faleata No.

Ale Vena Ale (FAST), Ulu Bismark Fuluasou Crawley (Independent) Siumu

Faalogo Kapeli Faalogo Lafaele (Independent), Tu'uu Amaramo Sialaoa Pagamalie (HRPP), Tu'uu Anasi'I Leota (FAST)

Vaa-o-Fonoti

Feutaga'iimealelei Osovale Brown (CDRP), Leausa Take K Naseri (HRPP) and Mau'u Siasoi Puepuemai (FAST).

According to the Electoral Commissioner Tuiafelolo John Stanley one of the candidates is flying under the banner of the newest political party the Constitution Democracy Republic Party (CDRP).

This party was officially registered as a Political party on the 24th of this month (August).

Any candidates that might change their minds on running in the by-election have the opportunity to withdraw if they wish.

NEW VOTERS

At the General Elections of 2021 the Electoral Roll for Faleata No. 4 recorded 2171 registered voters.

As of Friday 25th August 2023 when the rolls were officially closed OEC recorded an increase to 2253.

New voters for this constituency, 96.

Siumu on the other hand recorded a total of 2191 registered voters in the General Elections over a year ago as of today the total is 2259.

New voters for Siumu according to the Commissioner is 113.

Vaa-o-Fonoti however lost two voters from its electoral roll he said.

In 2021 the total number of voters was 1672 today it is 1670 and new voters has accumulated to 50.

These figures are a result of removing names of voters who have passed away, transferred out from this constituency and transferred into these constituencies and new registered voters says the commissioner.

Pre-Polling which Tuiafelolo reminded is scheduled for 13 September.

This is specifically for the elderly those 65 years and older and those on shift work.

The later are those unable to make the times Pre-Polling takes place.

The by-elections will take place on 15th September 2023.



Born in Australia, Haylani faced a lot of cultural differences growing up, and even in religious terms as her father is Buddhist and her mother is a Christian.

So, Haylani has come to the decision that when she has her own family, they will be moving to Samoa giving them the opportunity to learn the Samoan culture and language at a very young age, something she did not have when she was a young girl in Australia.

In a week, she will be crowning one of the 10 contestants in this year's Digicel Miss Samoa Pageant and tells all of them to have the desire to serve.

"The only reason why I am sitting right in front of you is because of God. He's put this in my path and has given me this opportunity now I can learn and grow after this. I have gained skills, I have gained knowledge and now I can apply it into the rest of my life and even teach my kids."

Thanks to the Government's \$1million District Development Project students from Letogo Primary School are reeling in its benefits.

The school recently launched three projects under the financial assistance of \$100,000 contributed to Letogo by the District Development Committee for enhancing the development of education in the village.

The students will now have a go-to library on the school premises, a new hall to keep them sheltered from the scourging sun when events are hosted outside classrooms and a new water fountain tap to keep them hydrated.

Minister of Education, Sports and Culture Seuula Ioane Tuā'au in his keynote address urged the students and staff to take care of their assets.

He told the students there was a time in his teaching career back in 1976-1977 when he first came to the Letogo Primary school.

Facilities were not in a good standard then but he was shocked to drive into the gates on the day of the launch to find that the school has completely changed for the better.

The minister wished all the students all the best and may they produce pastors, teachers, police officers, Ministers, doctors in the future.

Tagaloa Ruta Folau, Principal of the school thanked the Aii and Faipule for giving priority to the education of the young people of Letogo despite there being various developments that required this financial assistance.

She also acknowledged the New Zealand High Commission, the Pauga family from Laulii and the Church of Jesus Christ of Latter-day Saints for their continuous support towards the school's development through books and other resources.

This is not the first time that the Church of Jesus Christ of Latter-day Saints Church has provided support towards the school.

She also thanked the parents, school committee, her staff, MESC, CEO's, ACEO's, Principals of other schools and guests for

their endless support.

Tufalelulelu Faapiano Pilimai mayor of the village said the \$100,000 was part of the Letogo village's share of Vaimauga No. 1's \$425,000 from the \$1million District Development Project.

He acknowledged the project noting that if it were not for this financial assistance they would not have been able to bring this project to fruition.

And although the funds were not enough due to the high costs of materials for the projects the village joined forces to make it possible by contributing financially to the development.

The projects are;

- the library construction included painting, desks and chairs, and donations of computers and schools books
- the water fountain tap including 4 large waters tanks
- the school hall for shelter for assemblies and prizegivings

The mayor before ending his speech requested to the Minister of Education and MESC for a librarian to take care and attend to the student's needs.

According to the mother her husband and children all drive and already have their licenses.

With all her children overseas and just her husband and her at their home it was necessary that she learnt how to drive herself to where she wanted or needed to be.

According to Olevia her journey to obtaining a driver's license is a very important journey for her.

Given she was the only remaining member

of her family who did not possess a driver's license this was her chance to show her children and husband she was just as capable.

"I wanted to beat them," she told Savali about obtaining a driver's license.


