## Cabinet appoints 2 new Ministers

*"Now is the time to review what we have been able to accomplish and to look to the future in the second half of the term that we are now proceeding," Prime Minister Fiamē Naomi Mataafa.*

(GOVT. PRESS SECRETARIAT); Prescribed by law amendments passed by Parliament several years ago to increase the number of Cabinets by two to strengthen the Governments' decision-making, Cabinet this week proceeded with the selection and approval of the two new Ministers.

They are newly elected Member of Parliament, Lautimuia Uelese Afoa Vaai appointed as the Minister of Finance, heading the Ministry of Finance. Hailing from the Electoral Constituency of Vaimauga #3, Lautimuia is also appointed as Minister of Labour, in charge of Samoa's Labor Mobility and the Seasonal Workers Programs with Australia and New Zealand.

His predecessor, Mulipola Anarosa Ale Molio'o is reassigned to take over the Ministry of Women, Community and Social Development, (M.W.C.S.D.)

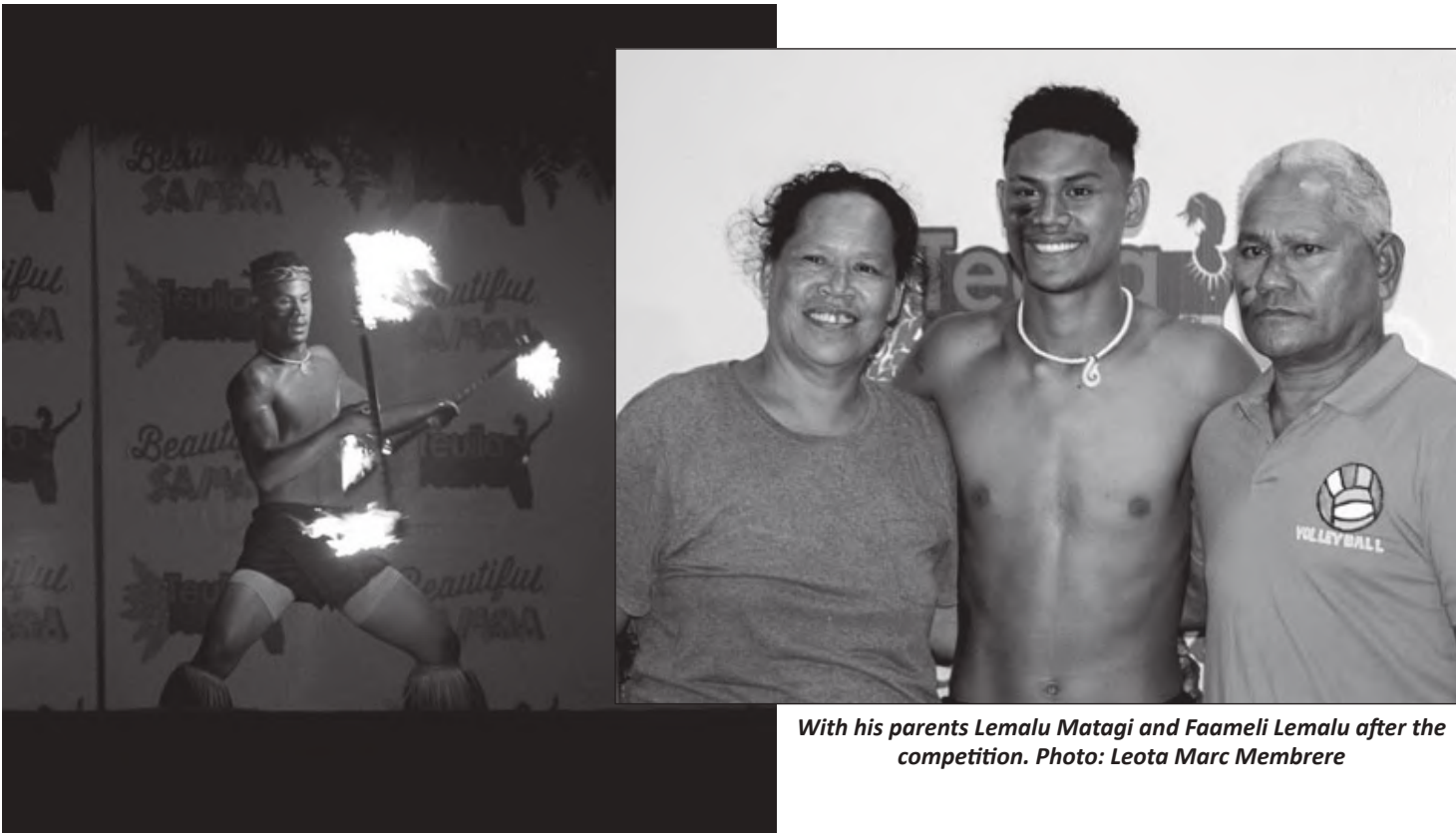

19 year old Han Lemalu from Matautu Lefaga has emerged victorious in this year's Teuila Festival Siva Afi competition.

Han went up against 7 other fire knife finalists on Tuesday night from Samoa and one from New Zealand.

Han showed a spectacular display of the art of fire knife dancing, showing the world that Samoans do not fear fire.

Dancing in front of hundreds of people, Han was able to show how skilled with not just one knife but two he is.

Speaking to the media on Tuesday after being announced the winner, Han was thankful to the Lord for what he has achieved and also thankful to his family for the support.

"This is my first competition and I am happy that I have achieved what I dreamed to achieve for Teuila," he says.

Han had first learned how to fire dance when was in Year 5 and from there he developed his talent. He was taught by his cousins who are fire knife dancers in Hong Kong, who wanted Han to carry on the art of fire knife dancing in their family.

To further enhance his talent, he is currently a fire knife dancer for Return to Paradise Resort.

Looking towards the future, the fire knife dancer is hoping to find opportunities overseas to showcase his skill to the world.

Han is the son of Lemalu Matagi and Faameli Lemalu. The eldest of 6 siblings he is currently studying engineering at the National University of Samoa (NUS).

## Inter-school Athletics Championships – Peaceful at last

from the 23rd, 24th and 25th of August this year it ended without a single violent brawl between schools.

In previous years, the Savalalo Bus terminal has always been the scene of disorder and dangerously unruly behaviour with students fighting and violently thrashing each other.

These many incidents have always resulted with the Samoa Police, and Ministry of Education, Sports and Culture, and heads of schools involved coming together to find solutions.

In 2019 the inter-school athletics did not go ahead until Government at the time lifted the ban for the event to take place again in 2020. There was no event in 2022 due to Covid-19.

So someone must be doing something right that not a single fight has erupted between schools since the event closed.

Sale Faletolu, the President of the Samoa Secondary Schools Principal's Association, in an exclusive interview with the Savali, claims his colleagues were strongly advised that this was their responsibility.

According to Faletolu prior to the event Principals were strongly urged to take full responsibility of keeping their students under wraps to ensure there will be no fights between schools during or after the event.

"It is the principal's duty to enforce discipline in their schools."

And the zones competition have all finished without a single incident he added.

With SSAB Champ of Champs' on the 15th of this month Faletolu is keeping vigilant in prayer, that the event which will bring together top athletes from schools across Upolu and Savaii, will also end the same.

Another ultimatum is also in place and is procedure enforced by the Association says Faletolu.

Any schools with students involved in any form of violence will be penalised.

The penalty is banishment from competing at any of the national

school events especially at the inter-school athletics.

How long the ban will hold for depends on the severity of the involvement, says Faletolu.

But, says it is important that students are reminded and encouraged of the main purpose and focus for this event.

This is schools should be enjoying themselves not be causing any trouble and be cheering for their athletes and showing them support.

"Personally I don't like to hear or see kids fighting and I promote in my school, a no violence policy because this is not under their JD's as students."

It is this same policy that is extended to students when engaging at the Inter-school athletics.

Faletolu also reaffirms that principals are reminded and encouraged always to keep their mind at all times on importance of their responsibilities and duties to ensure that students are well disciplined.

Faletolu ascribes the violence and fights to mobile phone usage where students post negatively about other schools.

But says, Principals across the country have already discussed with their students, they can be prosecuted if they continue to practise this.

A challenge though for many students since this is something that is allowed at home where they freely utilise their phones as they wish says Faletolu.

But, as Principal also of Itu-o-Tane College, Faletolu revealed that mobiles are not permitted in his school and his students abide accordingly.

They are of course reminded they are there to be educated and not to engage on their mobiles during lessons and school time.

According to Faletolu every time the event – Interschool athletics is preparing to happen - Police presence is always requested.

Papali'i also took the opportunity to acknowledge members of the public who filmed a young man harassing an Asian visitor in the public bus stop recently.

That was weeks into the official opening of the Teuila Festival last Sunday at the EFKS Youth Hall at Sogi.

Samoa Tourism Authority when asked for a comment regarding training and upskilling of Samoa's tourism industry to ensure that the needs of visitors and clients to these

establishments are satisfactory claims that it is committed to continue trainings offered to the industry workforce to ensure delivery of consistent quality service to visitors.

## Cabinet appoints 2 new Ministers

Leatinu'u Wayne So'oialo remains as the Minister of Public Enterprises.

The second new Minister is Laumatiamanu Ringo M. Purcell from Safata #2 Electoral Constituency, appointed as the Minister in Charge of Sports and Recreation.

In announcing the Cabinet decision Wednesday evening, Prime Minister Fiame Naomi Mataafa also revealed internal Cabinet reshuffling and portfolios which now sees the Tourism Sector under her watch.

While her predecessor Toeolesulusulu Cedric Pose Salesa Schuster remains as the National Resources and Environment Minister with added portfolios which include the Land Board, the Samoa Trust Estates Corporation, (S.T.E.C.) and the Samoa Land Corporation (S.L.C.).

She assured the country that the appointments and reshuffling is to fulfill the legislative mandates and to accommodate the Governments' initiatives and issues which needs to be address.

proceeding," reiterated the Prime Minister in her announcement.


